Among the types of Personal Data that this Application collects, by itself or through third parties, there are: email address; Usage Data; Trackers; number of Users; session statistics; password; social media accounts; device information; number of sessions; session duration; operating systems; Data communicated while using the service; Contacts permission; Universally unique identifier (UUID); unique device identifiers for advertising (Google Advertiser ID or IDFA, for example); various types of Data; username; IP address; browser information; city; ZIP/Postal code; state; county; country; latitude (of city); longitude (of city); metro area; geography/region; geographic position.

Personal Data may be freely provided by the User, or, in case of Usage Data, collected automatically when using this Application.
